



Promotion Name: "Twin Towns MEMBERS MONEY BADGE DRAW"

Promotion Period

1. The "Twin Towns MEMBERS MONEY" promotion ("Promotion") commences at 6.05pm on Thursday 7th September 2017 and ends Thursday 29th March 2018 following the final draw.

Entry Requirements

1. Entry is open to all financial members of the club over the age of 18 years.
2. This promotion is **only available** for Twin Towns Services Club members
3. A members financial membership will be randomly generated through a random number generator and verified via eBet Gaming Systems membership program and announced over the Club's PA system
4. Member's must be present in the specific club for that month, and will have four (4) minutes to make themselves present to promotion staff at the draw location following the public system address.

Weekly Draws & Prizes

1. Weekly draws will be conducted every Thursday at approximately 6.05pm, 7.05pm (times will vary at each site due to DST, but are detailed in the below table).
2. The starting amount is \$5,000 for Week 1 and this amount will increase by \$5,000 each week if not claimed. Therefore, Week 2 would be \$10,000, Week 3 would be \$15,000, Week 4 would be \$20,000 (and months with five (5) Thursday's would be \$25,000)
3. The jackpot amount stops at \$20,000 if not claimed prior (or \$25,000 for the month of November 2017) and if not claimed at the final draw of the month at 7.05pm, the second chance draw will be conducted approximately 5 minutes following the draw.
4. Following the \$20,000 (or \$25,000 Nov.) Jackpot Week, the amount will reset to \$5,000
5. If a Badge draw is won at the 6.05pm draw, there will be no additional draw for that day at 7.05pm
6. The selected badge draw winners name will only be announced at the nominated venue for the month.

Draw Locations and Times

The below table indicates the draw locations and times across the promotion period.

Month	Venue and Draw Times
September 2017	Twin Towns Services Club – 6.05pm and 7.05pm (QLD time)
October 2017	Juniors – 6.05pm and 7.05pm (NSW time)
November 2017	Club Banora – 6.05pm and 7.05pm (NSW time)
January 2018	Twin Towns Services Club – 6.05pm and 7.05pm (QLD time)
February 2018	Juniors – 6.05pm and 7.05pm (NSW time)
March 2018	Club Banora – 6.05pm and 7.05pm (NSW time)

It is noted that draws conducted at Twin Towns Services Club will run or be conducted at AEST times (QLD) and draws conducted at Juniors and Club Banora will be conducted on NSW (DST) time.

Draw locations at each specific venue will be as per below;

Twin Towns Services Club – The Stage and announced over the public address system

Juniors – the Main Bar, and announced over the public address system

Club Banora – the Stage, and will be announced over the public address system, excluding the Island House

Public Address system notifications are subject to standard setups and locations. No additional areas will be added and announcements will be made as per daily operations announcements.

Second Chance Draw

1. A "second chance draw" will only be activated in the last week of each badge draw month
2. If, and at any value, the last weeks badge draw is not claimed, members will have the opportunity to claim a portion of the cash by an entry mechanic.
3. Following an unsuccessful final draw, ten (10) members whom are present will be drawn out of a barrel and each awarded one tenth of the jackpot prize. For example, if the jackpot remains unclaimed at \$15,000 at the last week of the month, ten members drawn and present will each receive \$1,500 cash.

Qualification and Entry into Second Chance Draw

1. To qualify for entry into the "second chance draw", members must spend a minimum of \$5 at a selected outlet(s) within the nominated draw location for that specific month. For example, if the draw venue is Club Banora, then the spend must be at Club Banora.
2. Selected outlets across the sites include the following;
 - a. Twin Towns Services Club – Images Bar and Coffee Shop, Harbour Bar, 1st on Wharf Bar, Flame Bar, Signatures Bar, Breezes Bar and Orient Bar.
 - b. Juniors – Juniors Bar
 - c. Club Banora – Banora Bar and Coffee Shop, Bistro Bar and Island House Bar.
3. Upon spending \$5 at the above outlets in the corresponding month of the draw, members will receive an entry ticket titled "second chance draw" which will also have their name and membership number printed.

- Entries into the second chance draw can only be earned at a rate of one (1) entry per day, which starts on the Friday after the third draw. Dates for when entries are available are tabled below.

- The maximum number of tickets per member per month is seven (7).
- Upon receiving a qualifying ticket following a purchase, the member must retain ownership of that ticket until the barrel is produced. Tickets will be issued from the point of sale system, and will not be reprinted unless in the event of technical failure whereby no ticket was generated following a successful purchase. Lost tickets will not be reprinted and tickets will not be kept by any staff.
- The "second chance draw" entry barrel will be presented on-site at 5pm (approximately one hour before the first draw) at the venues final monthly draw. It will then be emptied on the same night, should it be needed or not.
- Second Chance tickets can only be entered into the barrel on the night of the final draw. It will not be available earlier.
- Second chance winners tickets will be subject to scrutiny, and must only be from the venue of the draw and from purchases that previous week. Tickets cannot be accumulated over a number of weeks/months and cannot be used at other venues.
- If the Badge Draw is claimed at either of the draws on the final night, the second chance draw is forfeited.

General

- As with all promotions, members must use their own cards. Cards cannot be used by proxy.
- No cash prizes will be awarded after 10pm.
- Guaranteed maximum prize pool for the promotion/badge draw is \$130,000
- Prize Winners are advised that tax implications may arise from their prize winnings and they should seek independent financial advice prior to the acceptance of the prize.
- Twin Towns Services Club Limited is the promoter. 13. All entries become the property of the Promoter and will be entered into a database. The promoter may use the entrants name, address and telephone number for the distribution of prizes as well as future promotional, marketing and publicity purposes in any media.
14. In the event that for any reason whatsoever a winner does not take an element of the prize at the time stipulated by the promoter, then that element of the prize will be forfeited by the winner.
